Every document filed for recordation shall be captioned as to type of act on the first page, and shall have on the first page a margin of two (2) inches at the top, and one (1) inch at the bottom and sides. The type size shall not be less than eight (8) point. For any document not in compliance with these guidelines:

Filing and Recording Multiple Indebtedness Mortgage

\$25.00 - First Page
\$10.00 - each additional page
\$5.00 - each name after the 1st name indexed

Marginal Notations

\$3.50 - each

Every multiple indebtedness mortgage filed for recordation shall be captioned as a “Multiple Indebtedness Mortgage” or “Multiple Obligations Mortgage” on the first page, and shall have on the first page a margin of two (2) inches at the top and one (1) inch at the bottom and on each side, and all subsequent pages shall have a margin requirement of one (1) inch on all sides. In addition, the type size shall be not less than eight (8) point. For any document not in compliance with these guidelines:

\$10.00 - Per Document
